<u>Selection Notification No. 2</u> 2-Year M Pharm Programme (GPAT Qualified) <u>Session-2025</u>

Consequent upon the seats which remained vacant due to non-completion of admission formalities by some candidates, the candidate whose particulars are mentioned below have been selected provisionally for admission to 2-Year M Pharm programme (GPAT Qualified) under DA Category offered at Main Campus, University of Kashmir purely on the basis of valid GPAT score.

The admission of the candidates is subject to:

- 1. Production of all relevant original documents {Marks Card/s of qualifying examination, Domicile certificate, Reserved Category Certificate, (Character Certificate, Provisional Certificate of the Institution last attended (if applicable)) and Migration certificate (if needed);
- 2. Production of valid GPAT Score Card;
- 3. Production of eligibility cum revival of registration/migration form wherever applicable alongwith prescribed fee;
- 4. Fulfilling of minimum required eligibility conditions to be verified by the concerned Centre;
- 5. Production of an affidavit sworn in before 1st Class Judicial Magistrate stating that:
 - I am not pursuing any programme/course through regular mode;
 - All the submitted certificates/documents are genuine;
 - I shall strictly adhere to the rules and regulations of the University in toto;
 - I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
 - I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

The provisionally selected candidate shall download his/her online Admission Form from official website of the University of Kashmir <u>www.kashmiruniversity.net</u> by entering his/her Application Form No. and have to approach alongwith all the relevant original certificates and self-attested Xerox copies of certificates/documents to the **Head**, **Department of Pharmaceutical Sciences**, **University of Kashmir** for online acceptance of the admission form and deposition of prescribed Fee from 28-07-2025 to 30-07-2025 (working days only), after depositing the requisite fee, the fee receipt alongwith admission form and other related documents be submitted in the office of the concerned Department by or before 30-07-2025 (working days only). Any provisionally selected candidate failing to complete the admission formalities upto 30-07-2025 shall forfeit his/her right to admission.
