



**ADMISSION NOTIFICATION No.: 17 (B) of 2025**  
**Admission to PG Programmes (Distance Mode)**  
**Session-2025**

In view of availability of seats, fresh On-line Applications are invited from the eligible candidates who have passed the qualifying examination from recognized Universities /Institutions for admission to the below mentioned **PG Programmes offered** through Centre for Distance and Online Education (formerly Directorate of Distance Education), University of Kashmir for the academic session 2025. The candidates are advised to peruse the Prospectus-2025/Admission Policy, available on University Website thoroughly and check eligibility/other details before submitting their Application Forms:-

- a) **M Com**
- b) **MA Economics**
- c) **MA Education**
- d) **MA English**
- e) **MA/M Sc Mathematics**
- f) **MA Urdu**
- g) **MA Kashmiri**

**The candidates who have passed their qualifying examination (Bachelors) under Annual/Semester scheme/ Choice Based Credit System Scheme/NEP-2020 are eligible for admission to the PG Programme/s only in such subjects where he/she has earned at least 12 credits in Core or Generic Elective Courses at Under-Graduation Level. However, for the courses/programmes where there is open eligibility like MA Islamic Studies etc., the candidates having passed their qualifying examination in any discipline are eligible/can apply for admission to said programmes.**

**NOTE:**

1. **In adherence to the UGC guidelines, the University of Kashmir has adopted dual degree mode wherein a candidate can pursue two degrees simultaneously i.e., one in regular mode and another in distance mode.**
2. **Only those candidates shall be admitted in the PG programs whose cell number is linked with their Aadhaar Card.**

I) **Important dates:**

- On-line submission and last date for Application Forms **including deposition of fee is from 26-08-2025 to 27-08-2025.**
- **All dates notified are final and no extension shall be granted.**

II) **Submission of On-Line Application Forms:**

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

**Step-1:** Visit <http://www.kashmiruniversity.net> or [www.kashmiruniversity.ac.in](http://www.kashmiruniversity.ac.in) and click on "Admissions" tab on homepage.

**Step-2:** Click on the link for "Application Forms for PG Programmes (Distance Mode)" and enter your Graduation "**Registration No.**" and Click "**Next**".

**Step-3:** Enter the required details and Upload your latest passport size Photograph and click "**Next**".

**Step-4:** If there is any variation click on "**Previous**" button, make necessary corrections and then Click "**Submit**". Get a printout of the Form and note the Form No. for future reference.

**Step-5:** Deposit the non-refundable Application Fee of **Rs. 550/-** through Online mode only.

**Step-6:** Applicant can view the Application details by providing username and password. Applicant is required to make sure that "**Application Status**" on application form is "**Fee Received**" after 2 days otherwise application will be treated as incomplete and summarily rejected.

**Step-7:** Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain print-out of application form for future references.

III) **Hard Copies of the Application Forms and fee receipt :**

Candidates need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

IV) **Disclaimer:**

**Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form. Therefore, it will be the sole responsibility of the candidate to ascertain that he/she fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the Centre for Distance and Online Education at the time of completion of admission related formalities in respect of the selected candidates to a particular programme. The admission of the selected candidate will be rejected at any time if it is found that the applicant does not fulfill the eligibility criteria or has misrepresented/concealed any facts/information;**

V) **Other relevant information:**

• **Application Form/Fee Reconciliation Status:**

The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to **“Fee Received or Form Accepted”** or **“Fee Reconciliation is pending”**, the candidate should contact the **IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir**, alongwith Application Form, Fee receipt and all other documents, within two days after the last date of submission of Application Form i.e. upto **21-07-2025**; thereafter, no claim, whatsoever, will be entertained by the University;

• **Submission of Application Forms is subject to determination of eligibility for admission to the Programmes by referring to the Admission Policy-2025;**
