



**Selection Notification No. 23**

**4-Year B.Tech Programme**

**(General and Self-finance Quota) Session-2025**

Consequent upon the seats which remained vacant due to non-completion of admission formalities by some candidates, the candidates whose particulars are mentioned have been selected provisionally for admission to 4-Year B.Tech Programme offered at Institute of Technology, Zakura Campus and North Campus, Baramulla under General and self-finance seat quota purely on the basis of JEE Score, KUET Points and/or academic percentage obtained in 12<sup>th</sup> standard.

Fresh candidates (who haven't applied earlier) shall visit the Directorate of IT&SS for filling the application form and then only they can download the admission form.

The admission of the candidates is subject to:


1. Production of all relevant original documents {Marks Card/s of qualifying examination, Domicile certificate, (Character Certificate, Provisional Certificate of the Institution last attended (if applicable)) and Migration certificate (for those students who haven't passed the immediate previous examination through University of Kashmir)};
2. Valid JEE Score Card;
3. Production of eligibility cum revival of registration/migration form wherever applicable alongwith prescribed fee;
4. Fulfilling of minimum required eligibility conditions to be verified by the concerned Centre;
5. Production of an affidavit sworn in before 1<sup>st</sup> Class Judicial Magistrate stating that:
  - I am not on rolls at any other Institution;
  - All the submitted certificates/documents are genuine;
  - I shall strictly adhere to the rules and regulations of the University in toto;
  - I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;
  - I submit this affidavit under free will without any pressure, compulsion, fraud or coercion;
6. The candidates whose result of Mathematics as additional subject is awaited shall submit an additional affidavit sworn before 1<sup>st</sup> Class Judicial Magistrate to the effect that if they fail in the concerned subject their admission shall stand summarily rejected and they shall not claim refund of any dues.

The provisionally selected candidates shall download their online Admission Forms from official website of the University of Kashmir [www.kashmiruniversity.net](http://www.kashmiruniversity.net) by entering their

Application Form No. and have to approach alongwith all the relevant original certificates and self-attested Xerox copies of certificates/documents to the **Directors of concerned Campus** for online acceptance of the admission form and deposition of prescribed Fee from **12-09-2025 to 16-09-2025 (working days only) upto 04:00 pm**, after depositing the requisite fee, the fee receipt alongwith admission form and other related documents be submitted in the office of the concerned Campus by or before **16-09-2025 (working days only) upto 04:00 pm**. Any provisionally selected candidate failing to complete the admission formalities upto **16-09-2025 upto 04:00 pm** shall forfeit his/her right to admission.
