- I) The Candidates, whose particulars are mentioned below have been provisionally selected for admission to **4-Year B Pharm Programme** under **General/Self-finance Quota/NRI/NRI Sponsored** offered by this University purely on the basis of percentage obtained in the qualifying examination (12th).

- III) The provisionally selected candidates shall complete the admission form and visit the Department of Pharmaceutical Sciences, University of Kashmir for **completing the admission formalities by or before (Friday), 12th December 2025 (4:00 p.m.) on working days only**.

Important Note:

The Head, Department of Pharmaceutical Science, who is the Chairperson of Departmental Admission Committee, shall ensure that all the provisionally selected candidates possess the minimum required eligibility. The same may be verified with reference to the original documents/certificates of the candidate. The admission form of only eligible candidates should be accepted online and provisionally selected candidates allowed depositing online fees.

The admission of the candidates is subject to:

1. Production of all relevant original documents [Marks Certificate of qualifying examination, Character and Provisional certificates, Migration Certificate (wherever applicable)].
2. Production of eligibility cum revival of registration/migration form, wherever applicable, alongwith prescribed fee;
3. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department;
4. Production of an affidavit sworn in before **1st Class Judicial Magistrate** stating that:
