



## **Admission Notification No. 02 of 2026**

### **Diploma in Criminal Justice**

**(Through Distance Mode)**

### **Academic session 2025-26**

On-line Applications are invited from the eligible candidates for admission to the **Diploma in Criminal Justice** offered through Centre for Distance and Online Education, University of Kashmir. The eligibility, intake, mode of selection, duration and fee is as:

<b>• Eligibility:</b>	<b>Graduation in any discipline recognized as equivalent by this University.</b>
<b>• Course Duration:</b>	<b>One (01) Academic Year</b>
<b>• Intake Capacity:</b>	<b>Fifty (50)</b>
<b>• Programme Fee:</b>	<b>5000/-</b>
<b>• Mode of Selection:</b>	<b>Merit obtained in qualifying examination.</b>

Furthermore, those of the candidates who are already registered for any PG programme on regular basis can also apply for the above programmes in view of Dual Degree Provision.

#### **Important dates:**

On-line submission and last date for Application Form **including deposition of application fee of Rs. 550/- is from 30-01-2026 to 05-02-2026.**

#### **Mode of Selection:**

The selection of a candidate for the admission to the programme shall be strictly based on the Academic Merit of the qualifying examinations. Admissions shall be governed by the Admission Policy and relevant Statutes of University of Kashmir.

#### **Mode of applying:**

Candidates interested in seeking admission under these categories are advised to follow the below steps for filling of On-Line Application Form.

**Step-1:** Visit <http://www.kashmiruniversity.net> or [www.kashmiruniversity.ac.in](http://www.kashmiruniversity.ac.in) and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

**Step-2:** Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the **“Register as Student”**. Remember, the Username and Password for future reference.

**Step-3:** After successful Registration, login into the system for submitting On-line Application Form. Enter your **“Registration No.”** and Click **“Next”**.

**Step-4:** Enter the required details and Upload your latest passport size Photograph and click “Next”.

**Step-5:** If there is any variation click on “Previous” button, make necessary corrections and then Click “Submit”. Get a printout of the Form and note the Form No. for future reference.

**Step-6:** Deposit the non-refundable “Application Fee of Rs. 550/- through Online mode only.

**Step-7:** Applicant can view the Application details by providing username and password. Applicant is required to make sure that “**Application Status**” on application form is “**Fee Received**” after 3 days otherwise application will be treated as incomplete and summarily rejected.

**Step-8:** Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain print-out of application form for future references.

### **Submission of downloaded Application Forms (Hard copy):**

The candidates after submitting their On-Line Application Form need not submit hard copy and must keep Hard Copy of the Application Form with them for reference. Fee Deposition and fee reconciliation shall be treated as Form submission.

### **Additional information:**

The candidates must check the fee status of their Application Forms after three days from the submission of on-line Application Form.
