Integrated Masters Programme in Business Administration (IMBA) (Session-2026)

On-line Applications are invited from eligible candidates who have appeared in the UGAT-2026 and have obtained valid **UGAT Composite Percentile Score** for admission to **5-Year Integrated Masters Programme in Business Administration (IMBA)** offered at Main Campus, University of Kashmir, Hazratbal, Srinagar for the academic session 2026. Admission to these programmes shall be governed by the Admission Policy and the relevant Statutes governing admissions:

I) Eligibility:

The applicants must have:

- passed Higher Secondary Part-II (10+2) examination from any recognized Board or equivalent examination with at least 50% marks in case of Open Category and 45% marks for Reserved Categories;
- obtained valid composite percentile score in the **UGAT-2026** (The selection to the programme shall be based on positive composite percentile score obtained by a candidate in **UGAT-2026**);

Detailed eligibility criteria for the above Programmes offered by the University are mentioned in the Prospectus-2026 available on the University Website www.kashmiruniversity.net under the tab **Admissions**.

II) Important dates

On-line submission and last date for Application Forms from 25-06-2026 to 04-07-2026. The notified dates are final and no extension shall be granted.

III) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

Step-1: Visit <http://www.kashmiruniversity.net> or www.uok.edu.in and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the "**Register as Student**". Remember, the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form.

Step-4: Enter the required details and Upload your latest passport size Photograph and click "**Next**".

Step-6: If there is any variation click on "**Previous**" button, make necessary corrections and then Click "**Submit**".

Step-7: **Deposit** the non-refundable Online **fee of Rs. 550/-** . Get a printout of the Form and note the Form No. for future reference.

Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "**Application Status**" on application form is "**Fee Received**" after 3 days otherwise application will be treated as incomplete and summarily rejected. Under such conditions, candidates can post a query through online mode only

Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush.

IV) Hard Copy of Application Form and fee receipt:

A Candidate need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

V) Disclaimer:

Directorate will not check/verify the academic/category certificates etc. of the candidates at the time of Online submission of application form and it will be the sole responsibility of the candidate to ascertain that he/she fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Department at the time of completion of admission related formalities in respect of the provisionally selected candidates to a particular programme. The admission of a provisionally selected candidate will be rejected at any time if it is found that the applicant was not fulfilling the eligibility criteria on the date fixed for the purpose or has misrepresented/concealed any facts/information;

VI) Other relevant information:

- **Application Form/Fee Reconciliation Status:**

A candidate must check the status of their Application Forms after three days of its online submission. In case, the status of his/her Application form is not updated to "**Fee Received**" or "**Fee Reconciliation is pending**", a candidate should post a query online from the dashboard and if a query does not get resolved, a candidate may contact the **IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir**, alongwith Application Form, Fee receipt and all other documents, within two days after the last date of submission of Application Form i.e. upto **07-07-2026**; thereafter, no claim, whatsoever, will be entertained by the University;

- **Submission of Application Forms and selection is subject to determination of eligibility for admission to the Programme by reference to the Admission Policy-2026;**
- **Notification for Self-financed Seats shall be issued on 06-07-2026 and the link for submission of online application form shall be made available from 06-07-2026 to 10-07-2026;** however, only those candidates shall be eligible for admission under Self-financed Seats Category, who have applied for the programme and have valid **UGAT Composite Percentile Score**.
- **Notification for NRI and NRI Sponsored seats has been issued and the link for submission of online application form shall be made available from 25-06-2026 to 10-07-2026;** The candidates interested in applying under NRI and NRI sponsored seats quota shall keep relevant documents available: a) NRI Certificate; b) NRI Sponsorship document.
