- I) Consequent upon the seats which remained vacant due to non-completion of admission formalities by some candidates, the candidates whose particulars are mentioned below have been provisionally selected for admission to 4-Year B. Tech Programme under **NRI/NRI Sponsored Quota** offered at Zakura Campus University of Kashmir strictly on the basis of percentage obtained in the Qualifying examination.
- II) Provisionally selected candidates are required to download their “**Admission Form**” from the official website of the University under “**Admissions**” tab on the home page and click on “**Submit Admission Form for 1st Semester**” from **24th July 2026** by entering **Application Form Number** and **DOB**.
- III) The provisionally selected candidates shall complete the admission form and visit the concerned Department for **completing the admission formalities by or before 29th July 2026 (4:00 p.m.)**.
- IV) **The admission of the candidates is subject to:**
1. Production of all relevant original documents {Marks Card/s of qualifying examination, Domicile certificate, Character & Provisional Certificates of the Institution last attended and Migration certificate (if applicable)};
 2. Production of Family Tree clarifying therein the relation with the sponsor duly certified by the concerned Tehsildar (admission cannot be granted without production of pedigree/family tree attested by Tehsildar of the concerned area);
 3. Production of “Relationship Declaration of the NRI/NRI Sponsor” attached to this notification at “Annexure-D”
 4. Production of eligibility cum revival of registration/migration wherever applicable along with prescribed fee;
 5. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department / Centre/ Campuses with reference to the original documents;
 6. Production of an affidavit sworn in before **1st Class Judicial Magistrate** stating that:
 - **I am not pursuing any programme/course through regular mode;**
 - **All the submitted certificates/documents are genuine;**
 - **I shall strictly adhere to the rules and regulations of the University *in toto*;**
 - **I understand that in case of any misinformation or concealment of any information or indiscipline, my admission to the programme shall be cancelled and I shall be subjected to legal action;**

- V) The provisionally selected candidates shall download their online Admission Forms from official website of the University of Kashmir www.kashmiruniversity.net by entering their Application Form No. and report alongwith all the relevant original certificates and self-attested Xerox copies of certificates/documents to the **Director, IoT, Zakura Campus** for online acceptance of the admission form and for deposition of prescribed Fee from **22-07-2026 to 29-07-2026 upto 4:00 pm (working days only)**, after depositing the requisite fee, the fee receipt alongwith admission form and other relevant documents be submitted in the office of the concerned Department by or before **29-07-2026 upto 04:00 pm (working days only)**. Any provisionally selected candidate failing to complete the admission formalities upto **29-07-2026** shall forfeit his/her right to admission.
- VI) All Notifications / circulars / lists are being uploaded on the official website of the University www.kashmiruniversity.ac.in or www.uok.edu.in which shall be deemed to have been served upon all candidates.
