Admission to 2-Year Master Programmes (Distance Mode)
Session-2026

On-line Applications are invited from the eligible candidates who have passed the qualifying examination from recognized Universities /Institutions for admission to the below mentioned **2-Year Masters Programme offered through Centre for Distance and Online Education (formerly Directorate of Distance Education)**, University of Kashmir for the academic **session 2026**. The candidates are advised to peruse the Prospectus-2026/Admission Policy, available on University Website thoroughly and check eligibility/other details before submitting their Application Forms:-

- a) 2-Year Masters in Commerce**
- b) 2-Year Masters in Economics**
- c) 2-Year Masters in Education**
- d) 2-Year Masters in English**
- e) 2-Year Masters in History**
- f) 2-Year Masters in Islamic Studies**
- g) 2-Year Masters in Kashmiri**
- h) 2-Year Masters in Mathematics**
- i) 2-Year Masters in Urdu**

The candidates who have passed their qualifying examination (Bachelors) under Annual/Semester scheme/ Choice Based Credit System Scheme/NEP-2020 are eligible for admission to the PG Programme/s only in such subjects where he/she has earned at least 12 credits in Core or Generic Elective Courses at Under-Graduation Level. However, for the courses/programmes where there is open eligibility like MA Islamic Studies etc., the candidates having passed their qualifying examination in any discipline are eligible/can apply for admission to said programmes.

NOTE:

- 1. In adherence to the UGC guidelines, the University of Kashmir has adopted dual degree mode wherein a candidate can pursue two degrees simultaneously i.e., one in regular mode and another in distance mode.**
- 2. Only those candidates shall be admitted in the Masters programmes whose cell number is linked with their Aadhaar Card.**

I) Important dates:

On-line submission and last date for Application Forms **including deposition of fee is from 29-07-2026 to 13-08-2026.**

II) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the **"Register as Student"**. Remember, the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form.

Step-4: Enter the required details and Upload your latest passport size Photograph and click **"Next"**.

Step-5: Upload your Marks Certificate of qualifying examination and Category certificate (if applicable) and click **"Next"**.

Step-6: If there is any variation click on **"Previous"** button, make necessary corrections and then Click **"Submit"**.

Step-7: Deposit the non-refundable Online fee of Rs. 550/- . Get a printout of the Form and note the Form No. for future reference.

Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "Application Status" on application form is **"Fee Received"** after 3 days otherwise application will be treated as incomplete and summarily rejected. Under such conditions, candidates can post a query through online mode only

Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush.

I) Hard Copy of Application Form and fee receipt:

A Candidate need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

II) Disclaimer:

Directorate will not check/verify the academic/category certificates etc. of the candidates at the time of Online submission of application form and it will be the

sole responsibility of the candidate to ascertain that he/she fulfills all the eligibility criteria for admission to the programme he/she is applying for. However, the documents will be verified by the concerned Centre at the time of completion of admission related formalities in respect of the provisionally selected candidates to a particular programme. The admission of a provisionally selected candidate will be rejected at any time if it is found that the applicant was not fulfilling the eligibility criteria on the date fixed for the purpose or has misrepresented/concealed any facts/information;

III) Other relevant information:

- **Application Form/Fee Reconciliation Status:**

A candidate must check the status of their Application Forms after three days of its online submission. In case, the status of his/her Application form is not updated to **“Fee Received”** or **“Fee Reconciliation is pending”**, a candidate should post a query online from the dashboard and if a query does not get resolved, a candidate may contact the **IT Cell adjacent to DSW Office Near Rumi Gate, University of Kashmir**, alongwith Application Form, Fee receipt and all other documents, within two days after the last date of submission of Application Form i.e. upto **13-08-2026**; thereafter, no claim, whatsoever, will be entertained by the University;

- **Submission of Application Forms is subject to determination of eligibility for admission to the Programmes by referring to the Admission Policy-2026;**
