Selection Notification No.: 01/B.Ed. of 2026 Distance Mode (Session 2026)

- I) The Candidates, whose particulars are mentioned below have been provisionally selected for admission to **2-Year B.Ed. Programme through Distance Mode** under **General Quota** offered by this University purely on the basis of score obtained in the Kashmir University Entrance Test held on **30-08-2026**.
- II) Provisionally selected candidates are required to download their “**Admission Form**” from the official website of the University under “**Admissions**” tab on the home page and click on “**Submit Admission Form for 1st Semester**” from **3rd of September 2026 (Thursday)** by entering **Entrance Test Roll Number or Form Number** and **DOB**.
- III) The provisionally selected candidates shall complete the admission form and visit the Centre for Distance and Online Education, University of Kashmir (**Main Campus or Sub-Office, Bathandi, Jammu**) for **completing the admission formalities by or before Monday, 07th September 2026 (4:00 p.m.) on all days (Working and holidays)**.

Important Note:

The Director, Centre of Distance and Online Education, who is the Chairman of Departmental Admission Committee, shall ensure that all the provisionally selected candidates possess the minimum required eligibility. The same may be verified with reference to the original documents/certificates of the candidate. The admission form of only eligible candidates should be accepted online and provisionally selected candidates allowed depositing online fees.

The admission of the candidates is subject to:

1. Production of all relevant original documents [Marks Certificate/Transcript of qualifying examination, Character and Provisional certificates, Reserved Category Certificate (if any), and Migration Certificate (wherever applicable)].

Note: Since result has been recently declared and most of the candidates have to seek exit from their colleges, they may be allowed to submit NAD generated ‘semester-wise marks cards’ till they get the Official Transcript from the University.

2. Production of Inservice Teaching Experience Certificate of school education level or DE. El. Ed Certificate (original);

3. Production of eligibility cum revival of registration/migration form, wherever applicable, alongwith prescribed fee;
4. Fulfilling of minimum required eligibility conditions to be verified by the concerned Department/Centre/Institute/Campus/College;
5. Clearance be sought from the Academic Section in respect of candidates having qualified examination from Universities/Institutions other than Universities/ Institutions of Jammu, Kashmir and Ladakh;
6. Production of an affidavit sworn in before **1st Class Judicial Magistrate** stating that:

✓ I am DE. El. Ed candidate or in-service teacher candidate presently serving at _____ bearing Govt. recognition no. _____ dated: _____. ✓ I am not on rolls of any Institution for any Distance Mode programme; ✓ All the submitted eligibility certificates/documents viz Qualifying examination, Inservice In-service Teaching Experience Certificate or DE. El. Ed Certificate are genuine and authentic, incase documents proved fraud at any stage my admission shall be cancelled and I shall be subjected to any legal action; ✓ I shall strictly adhere to the rules and regulations of the University of Kashmir <i>in toto</i>; ✓ I understand that in case of any misinformation or concealment of any information or indiscipline or misconduct, my admission to the programme shall be cancelled and I shall be subjected to legal action; ✓ I submit this affidavit under free will without any pressure, compulsion, fraud or coercion.

7. The provisionally selected candidates shall approach, alongwith the admission form and all the relevant certificates and documents (original and self-attested Xerox copies) to the concerned Centre for verification of documents/ certificates and online acceptance of Admission form for depositing the prescribed Fee via online mode upto **7th September 2026**.
8. Centre for Distance and Online Education will be accepting forms on holidays as well. However, the selected candidates of this list should preferably prepare affidavit from judiciary on **3rd of September, 2026** as Friday and Sunday are holidays; **however, the selected candidates residing outside Kashmir Division can also complete the admission related formalities at Sub Office, Bathandi, Jammu.**
9. Any provisionally selected candidate **failing to complete the admission formalities upto 7th September 2026 (4:00 p.m.) shall forfeit his/her right to admission** and the resultant vacancy (ies), if any, shall be filled up from among the waiting list.
10. The Director is hereby informed to kindly forward the vacancy list (if any) on **7th September 2026** upto **04:30 p.m.**, so that waiting list is operated.
11. Please note that all the Notifications shall be made available only on the Official website of the University and notices shall not be published in print media nor shall any candidate be informed individually.

12. Notices uploaded on the official website of the University shall be deemed to have been served to the candidates.
