M.Pharm and B.Pharm programmes

(Session 2018)

On-Line Applications are invited from eligible candidates for admission to M.Pharm and 4-Years B.Pharm Programmes for the academic session 2018 at Main Campus, University of Kashmir. Admission to the courses shall be governed by the Admission Policy/PG Prospectus-2018 available on University website and relevant statutes.

### i) **Important dates:**

Submission of On-Line Forms	<b>From August 08, 2018</b>
Last date of submission of On-Line/Hard copy of Application Forms	<b>August 18, 2018</b>

### ii) **Eligibility:**

#### a) **M.Pharm.**

Should have passed, Bachelor of Pharmacy (B.Pharm.) from the University of Kashmir or any other Institute recognized by UGC/AICTE with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories,

#### b) **B. Pharm**

10+2 (Biology background) with 50% marks for Open Merit and 45% for Reserved category.

### iii) **Admission Criteria:**

#### a) **M.Pharm.**

Candidates shall be admitted to various specializations of M.Pharm Programme on the basis of merit prepared on VALID GPAT percentile score (2018) and shall have preference in admission.

**The Admission Notification for NON-GPAT eligible candidates for admission to the M.Pharm Programme shall be issued separately (if need arises).**

#### b) **B. Pharm**

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

### iv) **Submission of On-Line Application Forms:**

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

**Step-1:** Visit <http://www.kashmiruniversity.net> or [www.kashmiruniversity.ac.in](http://www.kashmiruniversity.ac.in) and click on Link **Admissions 2018**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

**Step-2:** Enter your "**Registration No.**" and Click "**Next**".

**Step-3:** Enter the required details and Upload your latest passport size Photograph and click "**Next**".

**Step-4:** Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click "**Next**".

**Step-5:** If there is any variation click on "**Previous**" button, make necessary corrections and then Click "**Submit**". Get a printout of the Form and note the Form No. for future reference.

**Step-6: Deposit the non-refundable "Application Fee of Rs. 250/- (including Rs. 150/- as IT Fee) for B.Pharm Programme candidate has to deposit Entrance Test Fee of Rs. 500/- plus Application Fee of Rs. 250/- i.e. Rs. 750/- and for M.Pharm Programme candidate has to deposit Processing Fee of Rs. 250/- plus Application Fee of Rs. 250/- i.e. Rs. 500/- through Online mode only.**

**v) Submission of downloaded Application Form (Hard copy):**

The M.Pharm candidates after submitting the On-Line Application Form candidates must submit the hard copy of the Application Form in the Office of the **Department of Pharmaceutical Sciences, University of Kashmir**, alongwith the self-attested copies of the following documents, failing which their candidature will not be considered. **However, the candidates applying for B.Pharm programme need not to submit the hard copy of their Application Form.**

- i) Copy of Valid GPAT Percentile Score of the examining authority;
- ii) Qualification examination certificates;
- iii) Category Certificate, if claiming admission under reserved category;

**VII) Additional information:**

- The candidates must check the status of their application forms after four days of online submission of application forms. In case, acceptance of form is not uploaded or fee reconciliation is pending, the candidate should contact the office of the **Department of Pharmaceutical Sciences, University of Kashmir**, along with Fee Receipt, and other relevant documents, within three days after the last date of submission of application forms. Thereafter, no claim whatsoever will be entertained by the University.
- The candidates are advised to regularly check university website, using log-in and Password for status and necessary instructions and updates.
- After completing the admission process for General Category seats, the notification for self-finance seats shall be issued. However, only those candidates shall be considered for admission in Self Finance seat category who have initially submitted their application forms for admission to General category.
