MBA (Craft Management and Entrepreneurship) Programme

On-line Applications are invited from eligible candidates for admission to MBA (Craft Management and Entrepreneurship) Programme offered at Craft Development Institute, Nowshehra, Srinagar for the academic session 2020. Admission to the programme shall be governed by the Admission Policy and the relevant Statutes governing admissions:

i) Eligibility:

Bachelors Degree in any discipline under 10+2+3 pattern or any other qualification recognized by the University of Kashmir as equivalent qualification, with 50% marks in aggregate under Open Merit Category and 45% in Reserved Category.

ii) Mode of Selection:

Candidates shall be admitted to the Programme on the basis of CMAT Score-2020, however, in case number of CMAT candidates is not available or not sufficient then entrance test shall be conducted, for which a separate notification will be issued by the University.

iii) Important Dates:

Issuance of On-line Forms	18-11-2020
Last date for submission of On-line of Application Forms	28-11-2020

iv) Submission of On-Line Application Forms:

The candidates are advised to follow the following steps for filling their On-Line Application Forms:

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions 2020**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate needs to register himself/herself before submitting the Online Application Form. For Registration with the System Click on the **"Register as Student"**. Remember, the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form. Enter your **"Registration No."** and Click **"Next"**.

Step-4: Enter the required details and Upload your latest passport size Photograph and click **"Next"**.

Step-5: Select the desired Preferences (After last date the Preference of Campus/College selected will not be updated/changed). Click **"Next"**.

Step-6: If there is any variation click on **"Previous"** button, make necessary corrections and then Click **"Submit"**. Get a printout of the Form and note the Form No. for future reference.

Step-7: Deposit the non-refundable **"Application Fee of Rs. 150/- (including Rs. 50/- as IT Fee) and Processing fee of Rs. 250/- "** i.e. Rs. 400/- through Online mode only.

v) Submission of downloaded Application Form (Hard copy):

After submitting the On-Line Application Form, candidates need to submit the downloaded Form (hard copy) in the office of the Dean School of Commerce and Management Studies, University of Kashmir alongwith the below mentioned documents:

- a) CMAT Score Card-2020;**
- b) State Subject Certificate;**
- c) Category Certificate (if applied under any Category)**
- d) Marks Certificates of the qualifying examinations;**

VII) Additional information:

- The candidates must check the status of their Application Forms after three days of its online submission. In case, the status of Application is not updated to **“Fee Received”** or **“Fee Reconciliation is Pending”**, the candidate should contact the **Directorate of IT & SS, University of Kashmir**, alongwith Application Form and all other documents, within two days after the last date of submission of Application Form. Thereafter, no claim, whatsoever, will be entertained by the University.
- **Submission of Application Forms are subject to determination of eligibility for admission to the Programme by reference to the Admission Policy-2020.**
