UG Admission Notification 2022 (Regular for Private affiliated Colleges) under (NEP) National Education Policy 2020 for under Graduate 1st - 2nd Semester Batch 2022

It is notified for information of all the concerned that the Registration forms for admission to the (BBA / BCA / B.Sc-IT / B.Com / B.A MCMP) 1st & 2nd Semester under National Education Policy (NEP 2020) for Bachelors Programmes in the Private Affiliated colleges of the University shall be available on the University official website: www.kashmiruniversity.net from **6th September 2022**.

1. The candidates who have passed their 10+2 class examination in full having secured not less than 45% marks in aggregate in case of Open Merit and 40% marks in aggregate in case of reserved categories shall be eligible for admission to the UG level programme.
2. For B.Sc-IT: 45% marks (Open) and 40% (Category) at 12th class level (Higher Secondary Part-II) in Science stream from J&K Board of School Education or any other Board/Institution equivalent thereto;
3. The main features of the programme are :-
 - All Bachelor's Degree programmes are full-time regular for the specified duration as per National Education Policy (NEP-2020), with Multiple Exit and Entry systems at various stages after even semesters, from the academic session 2022 and onwards.
 - As per the UGC Guidelines for Multiple Entry and Exit in Academic Programmes offered in Higher Education Institutions, candidates who secure a minimum CGPA of 7.5 in a three year Bachelor's Degree Programme may be allowed to exercise the option to continue studies in the fourth year of the undergraduate programme to pursue and complete the Bachelor's Degree with Research / Honours.

ONLINE applications are invited from eligible candidates of Jammu & Kashmir for admission to Regular Under Graduate Programmes (Under National Education Policy - NEP - 2020) in the **Private Colleges** affiliated with the University of Kashmir for the session **2022 - 23**. The eligible candidates can apply for more than one programme. ONLINE application forms shall be available w.e.f **6th September 2022 to 10th September 2022**.

For ONLINE submission of application forms, the candidates are advised to follow as under:-

- (i) Browse the Kashmir University official website: www.kashmiruniversity.net;
- (ii) Click on the UG Regular Under Graduate (Under National Education Policy-NEP-2020) programme for private colleges session 2022 - 23;
- (iii) Open the ONLINE form fill it up with choice of three Colleges in order of preference;
- (iv) Deposit the fee of Rs.500/- out of which Rs.50/- chargeable as IT Fee through Online Mode (Non-refundable);

- (v) Submit the auto-generated application form along with self attested copies authenticated by the Principal of the concerned college the following documents in the Colleges where admission is sought and the college concerned shall forward the same to the office of the College Development Council, University of Kashmir, Srinagar latest by **12th September 2022:**
- Matriculation Marks Certificate;
 - Marks Card of 12th Class (Higher Secondary Part-II);
 - Domicile Certificate/Last School Attended;
 - Reserved Category Certificate (if any) signed by the competent authority;
- a. The candidate/s are advised to make a choice of Major as well as Minor Subjects reflected in Annexure -I along-with the colleges where they intend to seek admission.
- b. It shall be mandatory for the candidates admitted in the colleges to attend the classes regularly as their attendance for eligibility to appear in the semester end Examination shall be counted from the date of commencement of Class Work.
- c. The Principals shall ensure that admission / classification is made strictly in accordance with the revised groups of subjects under NEP 2020 for the session 2022, available on University website;

Completion of Admission Formalities:

The concerned Colleges shall complete all admission formalities within the stipulated time. The dropees list of the selected candidates needs to be furnished by the respective colleges to the University immediately after the last date of admission.
