## II) Eligibility:

# a) M. Tech in Embedded Systems and Solutions (Main Campus)

B.E./B.Tech./B.Sc. Engineering in Electrical Sciences (Electronics, Electrical, Instrumentation, Communications, Computer Sciences), M. Sc. Electronics, M. Sc. Information Technology, M. Sc. Computer Sciences, MCA with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

## b) M. Tech in Computer Science and Engineering (Main Campus)

B. Tech/B E in Computer Science/Information Technology/Computer Engineering with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

# c) M.Tech in Power System and Control (Zakura Campus)

B. Tech/B E in relevant branch (Electrical Engineering) with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

# d) M.Tech in Design Engineering (Zakura Campus)

B. Tech/B E in relevant branch (Mechanical Engineering) with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

## e) M. Tech in Computer Science and Engineering (North Campus)

Graduation in Computer Science Engineering with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

#### f) M. Tech in Mechanical Engineering (SSM College)

B. Tech/B E in Mechanical Engineering with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

#### g) M. Tech in Electronics & Communication Engineering (Zakura Campus and SSM College)

B.E./B. Tech. in Electronics & Communication Engineering with 55% marks for general category and 50% marks for reserved categories in the qualifying examination from this University or from any other university as equivalent thereto by this University.

#### Furthermore, candidates appearing/having appeared in the qualifying examination can also apply provisionally on their own risk and responsibility, subject to fulfilling all eligibility conditions including acquiring minimum required percentage by or before 29<sup>th</sup> July, 2025.;

#### III) Mode of Selection:

Candidates shall be admitted to the Programme on the basis of merit prepared on VALID GATE score and shall have preference in admission. However, if the number of candidates having VALID GATE Score is less than the intake capacity, a separate admission notification shall be issued by the University and the selection against the remaining vacancies shall be made on the basis of the entrance test conducted by the University.

#### V) Submission of On-Line Application Forms:

The candidates are advised to follow the below steps for filling of On-Line Application Forms.

\_\_\_\_\_ Step-1: Visit http://www.kashmiruniversity.net or www.kashmiruniversity.ac.in and click on "Admissions" tab on homepage. Step-2: Click on the link for "Application Forms for M .Tech Programme" and enter your Graduation "Registration No. or Enrollment No." and Click "Next". Step-3: Enter the required details and Upload your latest passport size Photograph and click "Next". \_\_\_\_\_ Step-4: Select the desired Campus Preferences (After last date the Preference of Campus selected will not be updated/changed). Click "Next". \_\_\_\_\_ Step-5: If there is any variation click on <u>"Previous"</u> button, make necessary corrections and then Click "Submit". Get a printout of the Form and note the Form No. for future reference. Step-6: Deposit the non-refundable "Application Fee of Rs. 300/- (including Rs. 150/- as IT Fee) and Entrance Test fee of Rs. 250/-" i.e Rs. 550/- for one programme and Rs. 250/- for each subsequent programmes through Online mode only. Step-8: Applicant can view the Application details by providing username and password. Applicant is required to make sure that "Application Status" on application form is "Fee Received" after 3 days otherwise application will be treated as incomplete and summarily rejected. Step-9: Candidates in their own interest are advised to apply & submit application promptly and not to wait till the last date/time for applying online. Directorate shall not be responsible if candidates are not able to submit their applications on account of the last-minute rush. Please retain printout of application form for future references.

## VI) Hard Copies Application Forms and fee receipt :

Candidates need not submit the hard copy of the Application Form nor of fee receipt; however, they must take printout of the online submitted Application Form and fee receipt and retain it for future reference.

## VII) Disclaimer:

Directorate will not check/verify the educational/category certificates etc. of the candidates at the time of Online submission of application form for appearing in the written examination and it will be the sole responsibility of the candidate to ascertain that he fulfills all the eligibility criteria for admission to the programme he/she is applying for.
