3. In the event of damage caused to Bukharies/furnishing/furniture or building etc. the contractor should be liable to compensate the loss.
4. No coal residue what soever should be thrown in corridors, stair-case of the buildings while carrying/removing iron stoves and arrange for its proper disposal outside the university campus.
5. The sections/places where the bukharies are to be installed shall be identified by the officer concerned. No contractor shall be permitted to install himself any iron stove at any place.
6. The required hardcoke/firewood will be provided at **12:00 Noon.** No contractor/labour is allowed to enter the Estates Stores.
7. Extra Bukharies after office hours or for the holiday will be intimated to the Contractor by the officer concerned (Asstt. Registrar Estates) only.
